## Powerline Easement Maintenance

Great Lakes Energy has contracted with Thunder Bay Tree Service to perform powerline easement maintenance beginning in June. Thunder Bay personnel will be contacting each property owner for authorization and scheduling of this no cost maintenance.

Property owners will be given a choice between an environmentally friendly herbicide or mechanical removal of brush. Herbicide will not be used on any LAPOA common ground or along the main gate road.
