Unfinished Business:

- Eagle Island: Ron Race reported that recently a pick-up truck went off the easement to Eagle Island. Fortunately, there were no injuries. The next day, the owner called Ron requesting financial assistance to help cover the costs they incurred to maintain the easement to their island property. There is also one lot on the island that belongs to the Association. Historically, the Association has not maintained easements. There was no support to reimburse the homeowner for the costs he incurred to maintain the easement. The consensus of the board is for Ron to draft a simple letter to the owners indicating that although we sympathize with them, we cannot justify using Association funds for the easement. Ron will draft a letter and submit it for review. With the approval of the majority of the Officers, Mary will send it. Jeff Kennedy expressed concern about dead trees near the power lines on the island. Ron will contact Great Lakes Energy about them. Dying trees that have fallen into the water are the responsibility of the property owners. The Association also has many dying trees at our parks, but we don't have the funds to remove all of them. Carolyn reported that she spoke to someone at the USDA and we may be able to include some of the dying trees into the Forestry Plan. -Campground: Judy reported that the Campground lease contracts need some revision for next year. Unless there are objections, we will use our updated storage contract for now. There is a camper in the storage area right now for which we don't have a contract. Judy will send the owners a letter. The Campground will be doing some electrical upgrades. These expenses will impact next year's lease contracts, taxes, etc. Judy reported that there is a yearly camper in the Campground whose property was foreclosed upon by the county. The owners are no longer LAPOA members. The consensus of the board is that they must leave the Campground and their camper and belongings must be removed. They are camping now but must vacate within a week. Paul will inform the owner.
- -Signatures on letters: Mary Davignon explained to new board members that a previous board had authorized the majority of our Officers to approve letters sent on the board's behalf to members. Copies are sent to the entire Board. Unless anyone objects, we will continue this practice.
- **-Adjournment:** At 2:00, Trisha Fowler moved to adjourn. Ron Race seconded the motion and it passed without objection.
